**VOLUNTEER BOND PROGRAM – INFORMATION**

**Southwest Hockey Association is an organization whose success depends on its volunteers.**

Community Program Volunteer Bond is \$350 per family, and House League Volunteer Bond is \$200 per family.  
**Cheques that do not clear will be subject to NSF fees.**

A min. of **15 hours** is required for Community Program and a min. of **10 hours** is required for House League Program.  
 If your circumstances do not allow for the time commitment, you can “opt-out” and your payment will be processed at the time of receipt **OR** you can appoint another **responsible adult** to perform your duties; with **PRIOR approval** from the Director of Volunteers.

**VOLUNTEER BOND SUBMISSION – REQUIREMENT**

**FIRST EVALUATION SESSION, each family must submit this Agreement Form AND postdated cheque.**

**RESPONSIBILITIES**

1. Agree to ensure you meet the Volunteer Bond (VB) commitment **PRIOR** to the end of the season.
2. Submit the required paperwork, to ensure your hours are properly acknowledged & your cheque is not cashed.
3. Agree that while the Association VB obligation is to be fulfilled – I acknowledge that **I will also support** my team, coaches & manager, and will assist to ensure there is sufficient volunteer coverage throughout the season.
